I try not to get into politics too much in these articles, but political decisions have ramifications for all of us in various ways. One issue that is being discussed, in this Minnesota legislative session, is significantly increasing the mandated amount of renewable energy in a utility's generation portfolio. I think this is a bad idea!

First, let's consider that the electric grid is growing greener every day. Reliable and affordable energy is being delivered to homes and businesses with radically lower pollution and diminishing amounts of carbon. This greening of the grid is the result of changing market conditions, which are creating financial incentives to reduce our dependence on fossil fuels and increase our use of wind, solar and renewable enabling natural gas.

Despite our rapid adoption of renewable energy resources, some Minnesota legislators are proposing to dramatically increase Minnesota's Renewable Energy Standard (RES) which will sabotage current effective market dynamics causing higher renewables prices. If the renewables sellers know you are required to have more, they will hold out for premium prices. In addition, the renewable levels being proposed have never been seriously studied so we don't know how grid stability may be impacted.

A quick example from the polar vortex in late January. During that time, of dangerous 30+ degree below zero temperatures, the demand for electricity spiked. At that same time the amount of electricity generated by wind turbines plummeted because many wind turbines shut down automatically when it got too cold for them to operate. Uninterrupted electricity was available during the lifethreatening freezing cold conditions because of fossil fuel power plants that ran flawlessly and carried the bulk of the electrical load.

The current Minnesota RES is 25% renewables by 2025. Great River Energy, our power supplier, has already reached that level and has pledged to be 50% renewable by 2030. The current voluntary approach provides flexibility to diversify generation portfolios using an "all-of-theabove" approach. We need a balanced "all-of-the-above" generation portfolio approach to maintain the affordability, reliability and sustainability of our Minnesota and national electric grid.

But electric line workers are up to the task. These brave men and women are committed to safety, as well as the challenges of the job.

Kandiyohi Power Cooperatives' line workers are responsible for keeping power flowing day and night, regardless of national holidays, vacations, birthdays, weddings or other important family milestones. 
BENEFITS OF TREE TRIMMING

Preheat oven to 350 degrees. In a large skillet over medium heat, melt butter. Add garlic and cook until fragrant, 1 min. Whisk in flour and cook 1 minute more. Pour in milk, whisking constantly, and bring mixture to a simmer. Stir in cream cheese and Parmesan and simmer until sauce thickens, 2 to 3 min. Add lemon juice and parsley and season with salt and pepper.

Spoon a thin layer of sauce onto bottom of a baking dish. Spread sauce onto each cooked noodle and top with chicken, then roll up noodle. Place roll-ups in baking dish, seam-side down, and spoon over remaining sauce. Bake until chicken is warmed through, about 20 minutes.
